What is a contract "Yissakhar and Zevulun and how is it different from a traditional financial support for Torah scholars

The obligation of Torah study is one of the 613 mitzvot. It is possible to support someone who studies so that the "wages" of our study is maximum. It is for this purpose that a contract on the model of Issachar and Zevulun exists to provide opportunities for all Jews to perform to the best of the most important mitzvah of the Torah. As it is written in Choulkhan YoréDea Aruch (243, A): "*He who can not study because he does not know, or preventing him from doing his business, must support others who study. The Rama considers that person as if she herself had studied. He added that it is possible to make a contract and thus to share the merit of the study.*".

The basics of this contract back to the origins of Israel ... The tribe of Zevulun proposed to that of Issachar to provide material support in exchange for which it undertook to study the Torah. ... *When the people were astonished at the exceptional quality of fruits Holy Land, they told them, "It is thanks to the wise of Issachar, who devote themselves to the study."*

But even more, the salary of Zevulun exceeds that of Issachar! His reward will be greater because although Issachar does not study the Torah perfectly and selflessly Zevulun, meanwhile, has funded a perfect study! (Zohar vayehi). Therefore, the one who helps those who study Torah receives blessings from above and from below. It will benefit from wealth in this world, and it will have its share in the world.

Issakhars Zévoulouns and famous ...

- Efraim and Menashe 2 son of Joseph son of Yaakov
- The Rambam and his brother David Ben Maimon
- Tana Shimon brother Azariah, so named because his brother Azariah was a trader and supported by his work studying Shimon, he has had the merit of his name still affiliated with that of his brother.

This fraternity is so expensive in the eyes of Hashem that He puts beloved talmidei hakhamim in need! In order to benefit the entire Klal Israel and give them and their part in their study!

In 1939 (the day before the theft organized by Nazi Germany), the funds were missing again at the Yeshiva. Reb Elchanan Wasserman went to solicit a Jewish Baranovitch rich "do you not see that the world is upside down? he asked the man. It took you a lifetime to amass this huge fortune, which is now likely to confiscate without notice. The one thing you will never lose is the money you have devoted to the study of Torah, while there is still time. "The man was convicted and his contribution was very generous. (Rav Elchanan Wasserman Biography E.Raphaël P148)
